- 6. Review of the 2014 Season
 - a. Successes
- i. Mavericks increased number of players, increased skill level
- ii. Stingers had to cut players, had a good year, hosted a successful ++ provincials weekend
- iii. Heat good year, the coaches survived, increased number of players, 5 graduating juniors
- iv. Ravens small roster, good commitment from the midget players/coaches, won the division, Jace to assist with coaching in the coming season
- V. Cudas lack of commitment from players & coaches, lots of room for improvement, a committee has been informed to deal with commitment levels
- b. Opportunities for Improvement
 - i. Officiating it seems each season the same officials are assigned to tier III and their skill level declines each season. The officials assigned to provincials was of poor quality. Val (ALRA) informed the group that tier III is at the bottom of the pool for being assigned. 'be happy you are not a girls team because they are last' See other notes in provincials.
 - ii. Interlock between Tier II & Tier III the tier III teams would like to play some exhibition games against the tier II teams.
 - iii. Increase Tier III exposure

- C. Expansion there were no applications for new teams. A discussion around moving to Tier II occurred but the consensus was that we would wait until after 2015 to do this. It was explained by the commissioner that it should be done before we are done more teams.
- d. Potential Number of Teams for the 2014 Season Five to Seven teams with the following ... The Ravens voiced concern about low numbers and no goalie. The Wranglers expressed concern about lack of a coach and low numbers. Marty from the Sundevils attended the tier II meeting. Prior to his going into the meeting he expressed that they most likely would not have a tier III team in 2015. They will follow the regulations for withdrawing if/when the time comes.

- a. Play Off Date & number of teams tier III will progress from regular season games to provincials. There will be no play offs.
- b. Provincial Date July 17, 18 & 19
 - i. Format tournament style weekend with format being finalized once the number of teams was determined.
 - ii. Number of teams all league teams are to attend
 - iii. Selection of host it was strongly suggested by the ALRA that the provincials be held in Calgary to increase the possibility of enticing higher skilled officials to the games. With this in mind the teams agreed the host would be the Axemen Maverick with the Wranglers as a back up. High River offered as well and the ALRA rep agreed that High River would be a suitable location for officials.
 - iv. Penalty for failure to host it was decided that with all teams being invited to the provincials this would no longer be an issue and not a planned discussion item in future meetings
 - v. Hosting duties/expectations floor time, hotels, sponsorship, provincial merchandise, volunteers, raffles and other merchandise
