- 1. Call to order the meeting was called to order at 9:04am
- 2. Introductions teams introduced themselves to each other
- 3. Additions to the Agenda no additions were made to the agenda
- 4. Approval of 2017 Planning Meeting Agenda approved as circulated (Dan/Gene/all)
- 5. Approval of 2016 Planning Meeting Minutes approved as circulated (Dan/Shayne/all)
- 6. Commissioner Election Tracey Haining by acclimation
- 7. New Team Applications
  - a. Blackfalds Silverbacks approved (Dan/Dave/all)
- 8. Business Arising from 2016 Meeting Minutes
  - a. Warriors Defaults/games not played as scheduled
    - Much discussion occurred regarding the Warriors future participation with the Senior C division. The division felt that the Warriors team had failed to meet the hopes discussed in the 2016 Planning Meeting minutes.
    - Concerns are that the team is in bad standing, has not played games as scheduled by the RMLL, does not function cooperatively with members of the division. The biggest concern expressed is their refusal to travel to Grande Prairie to play the Chiefs
    - The team was approved to have additional affiliates per game. They were allowed to have up to 8 affiliates. Tracey stressed that this was only used once throughout the season. The division unanimously stated that other teams could have benefited from this request and felt that moving forward no teams should be given a permission to increase the number of affiliates they can utilize in a game.
    - The division voted unanimously to proceed with expelling the Warriors from the division
    - The RMLL Executive Director (Christine Thielen) and VP (Duane Bratt) were brought into the meeting to advise the division how best to proceed. A division meeting to further discuss the Warriors membership has been set for December 14, 2017 at 7pm. All teams, including the Warriors were verbally notified. With written notification being sent to same no later than end of day Monday, November 14 by Tracey Haining.

### Clarification of a forfeit, default, postponement and a rescheduled game –

Tracey explained the difference between a forfeit, default, postponement and a rescheduled game; how it affects a team financially, points/standings and the players 4 game rule based on the regulations. Tracey stressed that she is not in a habit of

approving of rescheduling games and the likelihood of her approving a request was slim to none.

b. ALA Funding Requests – Tracey circulated the ALA Funding Policy to the division. She explained that she plans to submit a funding request to assist with coverage of referee mileage and per diem for the 2018 season. She was prepared to submit for the 2017 season, however, missed the deadline and was refused an deadline extension by the ALA
