- 1. Call to order at 9:45 am
- 2. Attendance: Earl (Irish), Chris (Silverbacks), Leon (Erratic), Matt (Rage), Ryan (Rage), Connie (Pioneers). Missing: Tomahawks
- 3. Sr C Commissioner
 - a. Earl nominated Connie, seconded by Chris, all in favor : Carried. Connie will continue as commissioner
- 4. Reading and approval of 2013 Agenda
 - a. Motion to accept 2013 Agenda by Chris, seconded by Earl, all in favor: Carried
- 5. Adoption of 2012 Minutes
 - a. Motion to adopt 2012 minutes by Matt, seconded by Leon, all in favor: Carried
- 6. Business arising from the 2012 Minutes

 - b. Treasure cove Cup- teams can apply but if it's a conflict with playoff games the teams will need to negotiate times to get playoffs in.

- 11. Tomahawks status
 - a. Tomahawks were not present. Sr C Division to meet with Sr B division
- 12. Fighting: no changes, Sr C is low in fighting majors
- 13. Division awards and point leader awards: During provincial game awards will be given out
- 14. Social Media Regulation/code of conduct Regulation
 - a. Make teams and players aware of the RMLL guides for Social media and code of conduct
