8. Scheduling

• Playoffs and Provincials (I recommend a best out of three series higher seeded team will be the home team)

For the schedules the higher seeded team will be the Home Team. If there is any travel then all games need to be played on Friday, Saturday and/or Sunday if that is the case then there will be one (1) game on Saturday and Two games (2) on Sunday (if needed). If there is NO Travel then the Playoff games can start on a Wednesday night as long as both teams agree. All games need to be completed by their end date. All teams need to secure their floor time and arena before the END of the season

- Provincials will be held in the South for the 2014 Season
- Game starts 9pm on weekdays for some arenas
- Each Team needs to have a back up arena and it needs to be given to Christine

Regarding the Schedule for Regular season and for Playoff's was voted on and approved by all teams in attendance. A motion was made to not Change the Playoff schedule that what was put in place at The AGM would not be changed. (See attached copy for playoff schedule format)

No Music during game play. Music only allowed during warm-up, intermission and the end of the game

• 5 game incident Reg

This Reg has been changed if a player receives 5 GM in one season then that player will be suspended for Two (2) games and could also be sent to Discipline as well. The other Change is the GM a player gets when they are given two major penalties will not be counted as one of the GM applied to the 5gm rule. Ex: a player gets into a fight and that player get 5 min fighting and a GM, 5 Inst and a GM as well as a GM for 2 major penalties in one game(this will not count towards the 5 GM rule)

10. Coaches/ Bench Personal

- All bench personal needs to have the proper certification (even trainers) Have extra people available with these credentials
- All coaches certificates numbers needs to be Entered into the RMLL System at the beginning of the season or when completed by the end of the season
- Proper Referee evaluation form needs to be filled out and sent in with the game sheet. Sent in missing about 30%. Started good at the beginning of the year

Teams brought up that they would like to see where the info is being used. As soon as i get feedback I will forward onto the division

 If the Visiting team takes the Referee form with them it is now there responsibility to scan and send it in

- Why are so many Tier II coaches not taking the NCCP/Coaching Clinics
- Bench personal who have not attended any clinic will not be allowed on the bench(date of when the coaches are booked is needed for the 2014 season)
- All Bench personal needs to be responsible and respectful before/after and during the game to Referees, Parents and all players even people working the penalty box doing shot clock or time keeper
- Coaches and Club being held responsible for their players and fans

• Updated rules and regulations and Bylaws have been put in place please make sure all clubs and bench personal have read and understand them.

The Tier II Division has come up with a pilot plan for the 2014 season in regards to the amount of penalty minutes that teams and players that received during the 2013 season.

Any team who receives more than 650 penalty minutes in the regular season will receive a \$250.00 dollar fine.

Any team who receives more than 750 penalty minutes in the regular season shall be sent to the RMLL executive for a franchise review.

Any Individual player who receives 100 penalty minutes in the regular season shall receive a 2 game suspension

Any Individual player who receives 150 penalty minutes in the regular season shall receive a 3 game suspension will be sent to Discipline

Any player who receives a GM in the last 10 minutes of the game shall be given a 1 game suspension

This Pilot will be reviewed at the 2014 AGM.
